Otherwise, please affix an appropriate stamp if posted outside Hong Kong.

If you choose to receive all future Corporate Communication published on the Company's website at [www.espritholdings.com](http://www.espritholdings.com), please provide us with your email address and we will send you email notification of the publication of the relevant Corporate Communication on the Company's website as and when the Corporate Communication is sent to the shareholders of the Company. If no email address or an improper email address is provided, we will send a printed notification letter of the publication of the Corporate Communication on the Company's website to such Non-registered Holders by post.
