We invite you to select your preferred means of receipt and language of Corporate Communication by ticking ($\sqrt{}$) the appropriate box in the enclosed Reply Form and signing and returning the Reply Form to the Hong Kong branch share registrar of the Company, Tricor Secretaries Limited of 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong (the "Branch Share Registrar") on or before 14 September 2011 (the "Relevant Date") by post by using the postage pre-paid mailing label provided if posted in Hong Kong. Otherwise, please affix an appropriate stamp if posted outside Hong Kong.

If you choose to receive all future Corporate Communication published on the Company's website at www.espritholdings.com, please provide us with your email address and we will send you email notification of the publication of the relevant Corporate Communication on the Company's website as and when the Corporate Communication is sent to the shareholders of the Company. If no email address or an improper email address is provided, we will send a printed notification letter of the publication of the Corporate Communication on the Company's website to such Non-registered Holders by post.

If we do not receive the duly completed and signed Reply Form on or before the Relevant Date, until and unless you inform us by reasonable notice in writing, you will be deemed to have consented to receiving all future Corporate Communication by electronic means through the Company's website at www.espritholdings.com.

- (1) Both the printed English and Chinese versions of Corporate Communication will be available from the date of despatch from the Company or the Branch Share Registrar on request, or on the Company's website at www.espritholdings.com and Hong Kong Exchanges and Clearing Limited's ("HKEx") HKExnews website at www.hkexnews.hk.
- (2) You are entitled to at any time by reasonable prior notice in writing, either by post to the Branch Share Registrar, Tricor Secretaries Limited, 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong or by email at esprit-ecom@hk.tricorglobal.com to change your choice of means of receipt and/or language of the Corporate Communication.
